“THROWBACK AT THE TRACK SWEEPSTAKES” SPONSORED BY THE GOODYEAR TIRE & RUBBER COMPANY

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE OF THE FIFTY UNITED STATES AND THE DISTRICT OF COLUMBIA AND WHERE PROHIBITED OR RESTRICTED BY LAW. THIS SWEEPSTAKES IS INTENDED FOR PLAY IN THE UNITED STATES ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED IN THE UNITED STATES AT THE TIME OF ENTRY. PLEASE READ THESE OFFICIAL RULES CAREFULLY AS THE OFFICIAL RULES REQUIRE THAT ENTRANT WAIVES THE RIGHT TO A JURY TRIAL AND THAT DISPUTES ARISING OUT OF OR RELATING TO THIS SWEEPSTAKES BE RESOLVED IN ARBITRATION ON AN INDIVIDUAL BASIS, RATHER THAN BY CLASS ACTIONS, AND LIMIT YOUR RIGHTS AND REMEDIES IN THE EVENT OF A DISPUTE.

1. Entry Period: The “Throwback at the Track Sweepstakes” (“Sweepstakes”) commences at 12:00 PM EST on July 1, 2019 and ends at 11:59 PM EST on July 31, 2019 (“Sweepstakes Period”). The Sponsor’s time clock will be the official time keeping device for this Sweepstakes. All entries must be received by 11:59 PM EST on July 31, 2019. If entrant submits any entries into Sweepstakes via the purchase method specified below in Section 4, the qualifying purchase must be made during the Sweepstakes Period, but entrant will be given until 11:59 PM EST on August 2, 2019 to upload the invoice as instructed below to receive the Sweepstakes entry. All interpretations of these Official Rules and decisions made by Sponsor relating to the Sweepstakes are final.

2. Eligibility: The Sweepstakes is open to persons legally and physically residing in one of the 50 United States or the District of Columbia who are at least the age of majority in their state of residence at time of entry: 18 years of age in most states, 19 in Alabama and Nebraska, 21 in Mississippi. Employees, agents, directors of The Goodyear Tire & Rubber Company (“Goodyear” or “Sponsor”) and The Marketing Arm Inc. (“Administrator”), and their respective parent companies, affiliated companies, subsidiaries, partners, dealers, manufacturers, distributors, sponsors, advertising agencies, promotion and administration agencies and any entity which is involved in any aspect of the creation, production, operation, execution or fulfillment of the Sweepstakes (“Sweepstakes Entities” NASCAR, Inc, and its affiliates and each of their respective employees, shareholders, officers, directors, agents and assigns, (collectively with Sweepstakes Entities, the “Released Parties”) and their immediate families (*i.e.*, parents, spouse, siblings, children, grandparents, step parents, step children and step siblings, and their respective spouses, and those living in the same household, whether or not related) are not eligible to enter Sweepstakes.

By participating in this Sweepstakes, entrants: (a) agree to be bound by these Official Rules and by the interpretations of these Official Rules by Sponsor and by the decisions of Sponsor; (b) acknowledge compliance with these Official Rules; (c) represent and warrant that he or she meets all the eligibility criteria set forth in these Official Rules; (d) agree to comply with any and all applicable federal, state and local laws, rules and regulations; (e) acknowledge that Sweepstakes is in no way sponsored, endorsed, administered by, or associated with Twitter; and (f) agree to indemnify and hold harmless the Released Parties and Twitter from and against any and all liability arising out of or relating in any way to entrant’s participation in Sweepstakes and to release all rights to bring any claim, action or proceeding against the Released Parties and Twitter. This includes, but is not limited to, any and all claims, demands, damages and causes of action for personal injuries or death and/or damage to personal or real property, theft, loss or any other harm, suffered directly or indirectly from entrant’s participation in Sweepstakes or the receipt or acceptance, redemption, possession, use or misuse of the Prizes (hereinafter defined), and for any claim including claims based on defamation, publicity rights, invasion of privacy, copyright infringement, trademark infringement, or any other intellectual property related or other cause of action.

3. Sweepstakes Overview: This Sweepstakes has: (i) four (4) separate entry periods, as specified below (“Entry Period(s)”), each with its own drawing from among all of the applicable Eligible Entries (hereinafter defined) received to select the applicable Winner (hereinafter defined) associated with the drawing for that particular Entry Period; and (ii) one (1) grand prize drawing after the end of the Sweepstakes Period, as specified below, that will include all Eligible Entries received during the entire Sweepstakes Period. A total of thirteen (13) Winners will be selected. All times referenced are in Eastern Time.

Drawing No. 1 through Drawing No. 4 and the Grand Prize Drawing will collectively be referred to herein as ("Drawing" or "Drawings"). All Eligible Entries not selected during any one Drawing will remain in the pool of entries for any subsequent Drawing during the Sweepstakes Period.

4. To Enter: There are two (2) methods of entry.

Enter via Purchase: In order to enter via this method, entrants must: (i) make one (1) qualifying purchase of four (4) Goodyear tires during the Sweepstakes Period (all four (4) Goodyear tires must be purchased on one (1) transaction. Tire purchase excludes Dunlop and Kelly brand tires) ("Qualifying Purchase") and keep the receipt from that Qualifying Purchase; (ii) visit **throwbackatthetrack.com** and enter your email address; (iii) complete all required fields to register for the Sweepstakes, including agreeing to the Sweepstakes Official Rules; and (iv) follow the instructions to upload an image of your receipt from the Qualifying Purchase to receive one (1) entry into the Sweepstakes. Only fully completed entry forms and Qualifying Purchase receipts are eligible. **Message and data rates may apply if entrant enters Sweepstakes via mobile device.**

To Enter via Twitter: In order to enter via this method, entrants must: (i) log onto their Twitter account; and (ii) post the hashtags **#goodyearatdarlington** and **#sweepstakes** to receive one (1) entry into the Sweepstakes. Entrant will need to have a valid **non-private** Twitter account in order to participate in Sweepstakes via this method. Entrants can open a Twitter account for free by registering with twitter.com. **Entrant must not use more than one (1) Twitter account to enter via this method of entry. If an entrant is suspected of using multiple Twitter accounts to enter Sweepstakes, any entries received by such means will be void. Entrants must be in compliance with the Twitter Terms and Conditions and accept the Twitter Privacy Policy. Message and data rates may apply if entrant enters Sweepstakes via mobile device.** This method of entry does not require the entrant to make any purchase transaction.

Entries must not include, depict or make reference to any of the following: obscenity, inappropriate language, nudity, sexual explicitness, drug or alcohol use, violence, firearms/weapons, commercial products or services, unauthorized copyrighted, trademarked or patented properties, including brand names, logos, or trade dress, private property, material that promotes any activities that may appear unsafe or dangerous, or promotes any particular political agenda or message, material that is hateful, tortious, defamatory, false or misleading, disparaging, slanderous, libelous, or otherwise unlawful, material that violates or infringes another's rights, including but not limited to, rights of privacy or publicity, copyrights, trademarks, patents or any other intellectual property rights, material that promotes bigotry, racism, hatred or harm against any group or individual, or promotes discrimination based on race, ethnicity, sex, religion, nationality, disability, sexual orientation or age, and any other content, including but not limited to, text, images, graphics, photographs, captions and descriptions, data, codes or programs that could be considered inappropriate or offensive, as determined by Sponsor in its sole discretion.

All information submitted to Sponsor by entrants is subject to and will be treated in a manner consistent with Sponsor's Privacy Policy accessible at <https://www.goodyear.com/legal/online-privacy.html>. By participating in Sweepstakes, entrants hereby agree that Sponsor may collect and use their personal information in compliance with its Privacy Policy and acknowledge that they have read and accepted the Sponsor Privacy Policy. All information submitted by entrants is being provided to Sponsor and/or Administrator and not to Twitter.

There is a limit of five (5) entries per person, regardless of method of entry. There is a limit of one (1) Prize per person. If it is suspected that an entrant submits more than five (5) entries, only five (5) entries will be considered. In the event of a dispute over who submitted a winning online entry, the "authorized account subscriber" of the e-mail account used to participate in Sweepstakes at the actual time of entry, will be deemed to be the entrant. **It is the sole responsibility of the entrant to notify the Administrator in writing if the entrant changes his or her email address during the Sweepstakes Period.** The "authorized account subscriber" for online entries is defined as the natural person who is assigned an e-mail address by an Internet access provider, online service provider or other organization that is

responsible for assigning email addresses for the domain associated with the submitted e-mail address. In the event a winning account selected is a joint account, a total of one (1) Prize will be awarded in the name of the first-named account holder. Proof to Sponsor's satisfaction of being the authorized account subscriber may be required by Sponsor.

All entries submitted in compliance with these Official Rules and not disqualified are considered "Eligible Entries". All entries become the sole and exclusive property of Sponsor. Entries will not be returned and receipt of entry will not be acknowledged. Proof of entry will not be deemed to be proof of receipt of entry by Sponsor.

5. **Odds:** The odds of becoming a Sweepstakes Winner depend on the total number of Eligible Entries received during the Sweepstakes Period for each applicable Drawing.

6. **Prizes:**

Grand Prize: The Grand Prize Winner will receive a trip for the Grand Prize Winner and one (1) guest of Grand Prize Winner ("Guest"), to Darlington, South Carolina ("Destination") to attend Throwback Weekend at Darlington Raceway ("Event"), on or about August 30 – September 2, 2019, but subject to change in Sponsor's sole discretion. The trip will include: (i) round trip coach class air transportation for Grand Prize Winner and Guest which shall originate from an airport of Sponsor's choice near Grand Prize Winner's primary residence in the United States to Destination, with an approximate retail value ("ARV") of \$1,600; (ii) a three (3) day Event "Best Package" that includes: (a) reserved seating for Grand Prize Winner and Guest for race days; (b) general admission seating for Grand Prize Winner and Guest for practice day; (c) pre-race all-inclusive VIP access (subject to the standard terms and procedures of NASCAR and subject to NASCAR's sole discretion), on-track access for concert and driver introductions; (d) and three (3) nights hotel accommodations in Destination for Grand Prize Winner and Guest, which will be one (1) standard room based on double occupancy (meals, telephone calls, tips, gratuities, and other incidentals and costs are not included; and (e) motor coach transportation for Grand Prize Winner and Guest, to be taken together, between hotel and Event; Best Package ARV is \$1,970; (iii) one (1) \$500 pre-paid card for Grand Prize Winner (subject to the terms and conditions of pre-paid gift card), with an ARV of \$500; and (iv) one (1) Goodyear Vintage Racing Hat signed by Dale Earnhardt Jr, with an ARV of \$50, collectively (the "Grand Prize"). The total ARV of the Grand Prize is \$4,120. Sponsor reserves the right to substitute ground transportation in lieu of air transportation if the Grand Prize Winner resides within 100 miles of Destination and no compensation or substitution will be provided for the difference in Prize value. Grand Prize Winner and Guest must travel on the same itinerary.

PLEASE MAKE NOTE THAT THE GRAND PRIZE MUST BE TAKEN IN ITS ENTIRETY IN ORDER TO AWARD ANY ELEMENT OF THE GRAND PRIZE. IF THE GRAND PRIZE WINNER DOES NOT, FOR ANY REASON, ATTEND THE TRIP, THE GIFT CARD PORTION OF THE GRAND PRIZE WILL NOT BE AWARDED.

Weekly Prizes: Each of the four (4) Weekly Winners will receive: (i) one (1) Goodyear Vintage Racing Hat, signed by Dale Earnhardt Jr, with an ARV of \$50; and (ii) one (1) \$200 SiriusXM gift card (subject to the terms and conditions of the gift card) with an ARV of \$200, each a ("Weekly Prize"). The total ARV of each Weekly Prize is \$250.

Choice of seat locations to be determined by Sponsor in its sole discretion. Winners and Guest are responsible for all costs and expenses associated with Prize acceptance and use that are not specified herein as being awarded. Prize dates are subject to change in Sponsor's sole discretion. If a Winner is not available or able to accept the Prize, Winner privileges will be terminated and an alternative Winner may be selected from among the remaining applicable Eligible Entries received if time permits.

The Weekly Prizes and the Grand Prize will hereinafter collectively be referred to as ("Prize" or "Prizes"). The total ARV of all of the Prizes is \$5,120. The ARVs are subject to change based on current market conditions at time of Prize fulfillment, and the time of travel and the distance between departure and Destination for the Grand Prize Winner. Any difference between the ARVs and the actual values, if any, will not be awarded.

7. **Publicity Release:** By participating in Sweepstakes, each Winner grants to Sponsor, and its representatives, affiliates, licensees and assigns, the right and permission to record, film, videotape and photograph the Winner ("Images"). These Images will be owned by Sponsor. Sponsor and each of its designees shall have the right to use, re-use, reproduce, publish, display, exhibit, distribute, edit, adapt, post, stream, copy and exploit such Images, and all elements

embodied therein, including any names, likenesses, address, voice, conversation, biographical and Prize information and any other attributes of Winner, individually or with others, in whole or in part, in conjunction with other material, if any, in any and all media now known or hereafter devised, for the purpose of trade, advertising, publicity, promotion, or a Sweepstakes Winner List or any other lawful purpose whatsoever, in perpetuity, throughout the world, without additional compensation, consideration, notification or permission, except where prohibited by law.

8. Winner Selection and Notification: There will be five (5) Winners selected in random drawings from among all of the Eligible Entries as specified in Section 3 herein by Sponsor's independent judging agency, Administrator. The potential Winners will be notified as follows: (i) via direct message on Twitter if they entered the Sweepstakes via the Twitter method of entry and will be required to confirm his/her name, address and phone number within twenty-four (24) hours from when direct message is sent and then Administrator will attempt to contact the potential Winner via the telephone number provided; or (ii) via the telephone number provided at time of entry if they entered the Sweepstakes via the online method and by entering the Sweepstakes the entrant hereby grants permission to be contacted via telephone. **No messages will be left on answering machines or voicemail systems.** If a potential Winner does not confirm his/her contact information as requested within the twenty-four (24) hour time period, cannot be reached directly and/or does not meet the eligibility requirements, the potential Winner will be disqualified and an alternate potential Winner next in contention for Winner designation will be selected from among all remaining applicable Eligible Entries received.

9. Winner Verification: To be eligible to be declared a Winner and to receive the Prizes, the potential Winners must sign and return to Sponsor and/or Administrator, within two (2) days of issuance of such documentation from Administrator or Sponsor a complete and valid IRS Form W9 (when necessary) and an Affidavit of Eligibility and Release that: (a) releases the Released Parties and Twitter from any and all liability, loss, claims, demands, and causes of action for personal injuries or death and/or damage to personal or real property, theft, loss, or any other harm suffered directly or indirectly from potential Winner's participation in Sweepstakes, including, but not limited to, traveling to, preparing for and/or participating in any Prize related activity, or the acceptance, possession, or use or misuse of any Prize; (b) except where prohibited by law, grants Sweepstakes Entities the right to use potential Winner's name, picture and/or likeness, or biographical information or voice for trade, advertising and publicity purposes, in any media now known or hereafter devised, throughout the world, in perpetuity, without additional compensation or consideration or notification; and (c) any other release deemed necessary. Entry into Sweepstakes constitutes agreement to sign such release. If a potential Winner does not sign this release and return it within the time frame specified, the potential Winner may be disqualified and the Prizes forfeited. When such documentation is properly executed and providing potential Winners are otherwise in compliance with the Official Rules, potential Winners will each be determined to be a Sweepstakes winner ("Winner" and collectively "Winners").

Guest participating in Grand Prize with Grand Prize Winner will also be required to sign [the Guest's parent or legal guardian if Guest has not reached the age of majority in the jurisdiction in which he/she resides ("Minor")], a Liability/Publicity Release that must be returned along with the potential Grand Prize Winner's documentation as provided in these Official Rules within two (2) days of issuance. If the Guest is a Minor, he or she must be accompanied by his or her parent or legal guardian and such parent or legal guardian must be the Grand Prize Winner. If Grand Prize Winner chooses not to take a Guest, or if any Guest does not sign the documentation as provided in these Official Rules within the time frame specified then the Guest elements of the Grand Prize will be forfeited and the other elements of the Grand Prize shall constitute full satisfaction of Sponsor's obligation to award the Grand Prize. Grand Prize Winner and Guest agree to comply with all venue rules and regulations and agree not to act in an unsportsmanlike or disruptive manner.

Winners must also complete any additional documents provided by Administrator or Sponsor with respect to the Prizes and return them as instructed within the time frame specified or Winner may forfeit Prizes at Sponsor's sole discretion. If a potential Winner is unable to participate in or accept the Prize or any portion of the Prize for any reason, Sponsor will have no further obligation to the potential Winner. Prize or Prize documents returned as undeliverable will result in forfeiture of Prize. Sponsor expressly reserves the right to delay the announcement of the Winners for any reason Sponsor deems necessary. In addition, Sponsor reserves the right to select an alternate Winner in the event that any potential Winner fails to comply with these Official Rules or fails to execute the documentation within the time frame specified.

By participating in Sweepstakes, Winners and Guest acknowledge that the Released Parties have not and will not obtain or provide insurance of any kind relating to the Prizes and that Winners and Guest will be responsible for obtaining and paying for any form of insurance relating to the Prizes that Winners or Guest deem appropriate.

10. Prize Terms: The dates for fulfillment of the Prizes will be on or about August – September 2019, but subject to change in Sponsor's sole discretion. If for any reason any Prize is unavailable or any Prize or related event is delayed, cancelled or postponed, or for any other reason, Sponsor reserves the right to modify the Sweepstakes in its sole discretion and award a substitute Prize, or portion of Prize, of comparable or greater value as set forth in these Official Rules. No substitution, transfer, assignment or cash equivalent of the Prize, or any portion thereof, is permitted by a Winner or a Guest. The Released Parties shall have no responsibility or obligation to a Winner or a Guest who is unable or unavailable to, or who does not for any reason, accept or utilize the Prizes. All costs and expenses not specifically listed above as part of the Prizes, including, without limitation; passports or other travel documentation, transportation (unless specified as being included), any activation or service fees, meals, snacks, beverages, mini-bar, entertainment, tips, gratuities, souvenirs, personal expenses, damages to hotel rooms, baggage fees, travel insurance, departure taxes and fees, and any equipment to be used in connection with the Prizes, are solely Winner's responsibility. The Winner may be required to provide a credit card to the hotel to cover any incidental costs incurred. PRIZES ARE PROVIDED "AS IS". ENTRANTS ACKNOWLEDGE THAT THE RELEASED PARTIES HAVE NEITHER MADE NOR ARE IN ANY MANNER RESPONSIBLE OR LIABLE FOR ANY WARRANTY, REPRESENTATION OR GUARANTEE, EXPRESS OR IMPLIED, IN FACT OR IN LAW, RELATIVE TO THE PRIZES AND ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. Prizes pictured in online, television, print advertising, and other Sweepstakes materials are for illustrative purposes only. Arrangements for the fulfillment of the Prizes, including all travel arrangements, will be made by Administrator and/or Sponsor.

Sponsor will determine in its sole discretion the airline and hotel to be provided as part of the Grand Prize. All travel dates are subject to change in Sponsor's sole discretion. If Grand Prize Winner or Guest is not available or able to travel on the dates specified by Sponsor, Grand Prize Winner and Guest's privileges will be terminated and an alternative Grand Prize Winner will be selected in a random manner from the remaining Eligible Entries if time permits. Travel restrictions, conditions and limitations may apply. Travel arrangements are subject to availability and must be roundtrip. The Released Parties shall not be responsible for any damage to baggage or any cancellations, delays, diversions or substitutions or any acts or omissions whatsoever by the air carriers, hotels or other transportation companies or any other persons providing any element of the Grand Prize or associated with the Grand Prize. Grand Prize Winner and Guest must possess valid travel documents in order to travel.

11. Taxes: All Winners with Prize values of \$600 or over must supply Sponsor and/or Administrator with their social security number. An IRS Form 1099 will be issued in the name of Winner for the actual value of the Prize awarded if the actual value of Prize is \$600 or over. All federal, state and local taxes, and any other costs and expenses associated with acceptance or use of Prize not specifically provided for in these Official Rules are solely the Winner's responsibility.

12. General Terms: The Released Parties and Twitter are not responsible if Sweepstakes cannot take place, or if any Prize cannot be awarded due to delays, interruptions or failures due to acts of God, war, natural disasters, weather, acts or threats of terrorism, strikes, lockouts, labor disputes, work stoppages, fire, acts of government, or other events outside of the reasonable control of the Released Parties. If, for any reason Sweepstakes is not capable of running as planned, including, without limitation, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the reasonable control of the Released Parties, which, in Sponsor's sole determination, corrupts or affects the administration, security, fairness, integrity or proper conduct of this Sweepstakes, Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend Sweepstakes or any part of the Sweepstakes. If Sweepstakes or any part of the Sweepstakes is terminated or modified prior to the closing date of the Sweepstakes, notice will be posted on throwbackatthetrack.com if time permits and the Prizes will be awarded to Winners to be selected in a random drawing from among all of the remaining uncorrupted, applicable Eligible Entries received prior to any such event, or in any manner that is fair and equitable as determined by Sponsor in its sole discretion. Sponsor reserves the right to modify and amend these Official Rules from time to time during Sweepstakes for clarification purposes. Failure by Sponsor to enforce any term of these Official Rules shall not constitute a waiver of that provision.

The Released Parties assume no responsibility for and will disqualify entries that are: stolen, late, lost, illegible, incomplete, invalid, unintelligible, altered, tampered with, unauthorized, fraudulent, damaged, destroyed, delayed, misdirected, not received, postage due mail entries, or that have incorrect or inaccurate entry information, whether caused by any of the equipment or programming associated with or utilized in the Sweepstakes, or by any human,

mechanical or electronic error that may occur in the processing of the entries in Sweepstakes, or other errors appearing within the Official Rules or in any Sweepstakes related advertisements. The Released Parties assume no responsibility for any typographical or other error in the printing of the offer, administration of Sweepstakes, errors in processing entries, identifying the Winners, in the announcement of the Prizes and Winners, and the delivery of the Prizes, any problems or technical malfunction of any telephone network or lines, mobile phone, computer systems, online systems, servers or providers, computer equipment, software, failure of any e-mail or players on account of technical problems or traffic congestion on the Internet or on any web site, or any combination thereof, including, without limitation, any injury or damage to entrant's or any other person's computer system/software or mobile phone or other portable electronic device related to or resulting from participation or downloading any materials in Sweepstakes. The Released Parties are not responsible for the functionality of the Twitter platform, including changes that may interfere with the Sweepstakes or the ability of a potential entrant to participate in the Sweepstakes. Use of any device to automate or subvert entry is prohibited and any entries received by such means will be void. No software-generated, robotic, programmed, script, macro or other automated entries are permitted and any entries received by such means will be void. Sponsor reserves the right in its sole discretion to disqualify any person they suspect or find: (i) to have used a software generated, robotic, programmed, script, macro or other automated entry; (ii) to have tampered with the entry process or the operation of Sweepstakes; (iii) to be acting in a disruptive manner, or with the intent to annoy, abuse, threaten or harass any other person; (iv) to display behavior that will bring such Winner or the Released Parties into disgrace; (v) to have provided inaccurate information on any legal documents submitted in connection with Sweepstakes; or (vi) to be acting in violation of these Official Rules.
